Public Hearings

Under Section 34 of the Planning Act, a Public Hearing is being held for the purpose of receiving comments on a proposed Zoning Bylaw Amendment Application:

The purpose of this Zoning Bylaw Amendment is to rezone the property located in Part of Lot 10, Concession V; 976 Second Avenue, Town of Espanola from the Rural Residential (RR) Zone to the Rural Residential Special Exception Eleven (RR-11) Zone in order to permit a proposed private gym and fitness training studio accessory to a residential dwelling and recognize the reduced lot area.

Both written and verbal comments were received and included in the Council Agenda.

The Mayor asked for comments from the Public.

Ms. Laura Wright, an area property owner stated that she is against the proposed rezoning application. She stated that a commercial establishment should be kept in the downtown core, where the zoning is already in place. She is concerned that rezoning to permit this business will decrease her property value. Ms. Wright also stated that there would not be enough room for clients to park.

Ms. Shirley Burley addressed Council with her concerns regarding the application. She stated that she is a long time resident of the area, and had chosen to purchase a home

in this location because of the low traffic volume and the quiet setting. Ms. Burley stated that the current road conditions were already deteriorating; she is concerned that the business would create additional traffic flow, which would cause the Second Avenue to deteriorate further at a quicker rate.

She went on to add that the Post Office box for residents in the area is located in front of the property in question. She is concerned that residents will be unable to access it with their vehicles due to clients parking on the roadway.

Ms. Burley also expressed concerns with respect to health and environmental issues that may arise due to the increased usage of water and septic. She stated that all residents in that area are on private systems. She is concerned that an increase of waste water could jeopardize the quality of drinking water for all the residents. She asked if Council has considered this and if they had a plan.

Ms. Burley advised Council that in the Spring the street in front of 830 Second Avenue becomes a lake and is almost impassable. She asked Council what they planned to do about this as an increase in traffic on this road at that time of year would cause traffic issues. With they run storm sewers down to this area?

Mr. Frank Beer stated that although he does not live in this particular area, he does live in a residential area where one of his neighbours has a home based construction business. He stated that there is definitely an increase in traffic and there are issues with the flow of traffic. He commented that although Mr. Bulloch is currently suggesting a small clientele, growth is possible, traffic would mostly increase and overlap as a class ends the next one starts.

Mr. Dan Lagrandeur, a resident at 1020 Second Ave addressed Council with traffic concerns. He stated that he has a young family and decided to purchase a home in that location due to the light traffic, making it a safer location for his children. His children often walk the street to the mailbox and he is very concerned about safety issues that would arise with an increase in traffic.

The applicant Curtis Bulloch was present but did not address Council.
