# Item G2 POA Cost Recovery Rates

#### 15-149 B. Foster - R. Dufour

Be It Resolved That: Whereas the Municipal Court Managers' Association of Ontario has submitted a letter to the Ministry of the Attorney General requesting they review and increase court costs from \$5.00 to \$10.00 and also increase late fees from \$10.00 to possibly \$40.00.

Whereas these two requested increases are in response to a letter received from the Ministry of the Attorney General advising that effective January 1<sup>st</sup>, 2016 the Ministry is increasing the adjudication cost recovery rate from \$200 to \$300 per in-court hour and increasing the monitoring cost recovery rate to reflect the full cost of delivery services.

Whereas with these unforeseen increases, it is the hope of the Municipal Court Managers' Association of Ontario that these requested changes will help offset the increased costs that the Ministry is implementing in January, 2016.

Now Therefore be it resolved that the Town of Espanola supports the request submitted by the Municipal Court Managers' Association of Ontario to the Ministry of the Attorney General and requests that the Ministry of the Attorney General work with the Municipal Court Managers' Association of Ontario in partnership in moving ahead with the review and increase of court costs and that all Municipal Partners request the same.

# Item G3 Ovarian Cancer

#### 15- 150 R. Yocom - R. Dufour

Be It Resolved That: WHEREAS in 2015, over 2800 Canadian women will be diagnosed with ovarian cancer, the fifth most fatal cancer among females, and each year, 1750 women will die from the disease;

AND WHEREAS in Canada, 1 in 70 women will develop ovarian cancer in their lifetime. More Canadian women die from ovarian

cancer than all other gynaecologic cancers combined, including cervical and endometrial (uterine) cancers;

AND WHEREAS ovarian cancer remains difficult to detect; although the 5 year survival rate is approximately 90% when ovarian cancer is detected in its earliest stages, 80% of cases are diagnosed at an advanced stage where 5-year survival is only about 30%. Currently, no reliable screening test exists for ovarian cancer;

THEREFORE BE IT RESOLVED THAT: Council for the town of Espanola hereby declares September as Ovarian Cancer Awareness Month and encourages all residents to be aware of self care and intuitive and proactive health care.
